APPLICATIONS ARE INVITED FOR FILLING UP OF 04 (FOUR) POST OF PSYCHIATRIST PURELY ON CONTRACT BASIS IN CENTRAL JAIL, TIHAR, NEW DELHI.

1. Name of Post : Psychiatrist (on contract basis) in Central Jail Tihar  
(For six months or till the posts are filled up on regular basis)
2. Number of Post : 04 (Four)
3. Monthly remuneration : Rs.67,700/- per month  
(consolidated without any allowances)
4. Education Qualification  
Essential : (i) A recognized MBBS qualification included in the First or Second Schedule or Part II of the Third Schedule (other than licentiate Qualification) to the Indian Medical Council Act, 1956. Holders of Education qualification included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub-section (3) of Section (13) of the Indian Medical Council Act, 1956.  
(ii) Post graduate Degree / Diploma in the concerned super speciality mentioned in Section A of Schedule VI or equivalent.  
(iii) Three year's experience in the concerned super-speciality after obtaining the first post graduate degree or 5 years experience after obtaining the PG diploma.
5. Age : Not exceeding 45 years.
6. Mode of Selection : By interview (the applications shall be scrutinized and list of shortlisted candidates along with date of interview shall be displayed on the notice board of DDU Hospital by 4 : 00 pm on day of interview. No separate communications shall be sent to anybody).
7. Date / venue of Interview : 8<sup>th</sup> August, 2017 at 10 : 00 AM onwards at DDU Hospital, Hari Nagar, New Delhi-110064
8. Duly completed applications in all respect (alongwith all supporting documents) must reach office of Medical Director, DDU Hospital latest by 7<sup>th</sup> Aug, 2017 by 4 :00 PM. Incomplete applications or application received late shall be summarily rejected.
9. Other terms & conditions :  
(i) The contract will be entered into by the Central Jail Tihar for a period of six months, one day break would be given and the fresh contract shall be entered into depending upon the suitability of the persons engaged after assessing the work performance.

- (ii) The appointee is required to appear before a medical board for undergoing medical examination. Appointment will be given only after the candidate is found medically fit.
- (iii) The appointment is also subject to satisfactory verification of character and antecedents of the candidate in due course.
- (iv) The appointment can be terminated at any time (on either side) by giving one month's notice or by paying salary for an equivalent period without assigning any reason.
- (v) The appointee shall not be entitled to any benefit of provident fund, pension, gratuity, seniority which are available to the Government Servant appointed on regular basis.
- (vi) These appointee shall not be entitled to LTC for the duration of the contract.
- (vii) The appointee shall not be entitled to any TA/DA for joining.
- (viii) The contractual appointees will not be entitled for leave of any kind for study during the contract period.
- (ix) The contractual appointee shall be entitled for 6 days leave for six months of continuous service which can not be accumulated / carried forward.
- (x) This appointment is purely on contract basis and will not bestow upon him/her any claim for regular appointment.
