GENERAL TERMS AND CONDITIONS

1. **3% seats shall be reserved for physically handicapped persons as per rules.**
2. Number of the vacancies is provisional and subject to change without any notice.
3. Panel of wait listed candidates will be prepared for filling the post of SR for vacancies arising in future. The panel shall remain valid for 6 months or till fresh selection process is carried out whichever is early.
4. In case, SC/ST/OBC candidates are not available for SR, the post shall be filled for 89 days on adhoc basis from General Category Candidates and vice versa.
5. In case interview for all candidates is not completed on the scheduled date / duration the interview shall be continued on following working day.
6. In case scheduled date happens to be holiday for any reason, the scheduled activities shall be carried out on next working day.
7. No TA/DA will be paid for participation in selection process.
8. The appointment and services will be governed under Residency Scheme of Govt. of India.
9. All appointment shall be subject to medical fitness and verification of certificate of educational qualification /age/caste/submission of valid DMC registration certificate and internship completion certificate etc.
10. Medical Director being HOD of the institution shall reserve right to make just changes in the schedule/selection process in public interest.
11. The decision of the Medical Director shall be final under all circumstances.
12. The applicants are advised to read directions for filling the form very carefully and fill applicable form as applicable.

SPECIFIC TERMS AND ELIGIBILITY CONDITIONS AS APPLICABLE TO VARIOUS POSTS

TERMS & ELIGIBILITY FOR THE POST OF SENIOR RESIDENTS:-

- I. **QUALIFICATION:** MBBS with post graduate degree/DNB/Diploma or equivalent as per Residency Scheme in concerned specialty from a recognized university/Institute. Must not have not completed 03 years Senior Residency in any recognized institute including regular or adhoc basis. **In Superspeciality Branches, Preference will be given to candidates having Experience in Superspeciality**
 - II. **Age As on date of Interview :** Shall be maximum of 33 years for PG Degree and Diploma holder and 35 years for post Doctoral Degree holder as per Residency Scheme, as on date of interview. The age is relaxable up to 05 years for SC & ST and 3 years for OBC candidates (OBC candidates belonging to Delhi only).

- III. The candidates must have valid Registration with Delhi Medical Council or must have acknowledgment of having applied for the same, but before joining a valid DMC Certificate is Must.
- IV. Appointment will be initially for period of one year and will be extended further on yearly basis upto maximum of 03 years on the basis of satisfactory Work & Conduct report from concerned HOD and a written request from the Doctor concerned.
- V. **Pay Scale :** Shall be in accordance with 7th CPC guidelines as adopted by GNCT of Delhi.
- VI. **Internship :** Must have completed one year Rotatory internship on or after 30.06.2015. In case of Foreign Graduated should have passed FMG exam or completed the Internship on or after 30.06.2015. Whichever is later.
- VII. The candidates must have valid Registration with Delhi Medical Council or must have acknowledgment of having applied for the same, but before joining valid DMC Certificate is Must.
- VIII. Appointment will be initially for a period of six months extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD and written request from the Doctor concerned.
- IX. Candidate must have not completed one year's Junior Residency from any recognized Institution.
