INTERVIEW FOR JUNIOR RESIDENTS (AD-HOC) IN DDUH/WEST DISTRICT

A walk in interview for engagement of Junior Residents on purely ad-hoc basis for 89 days or till regular appointment is made by the government under any proposal or scheme, whichever is earlier is scheduled to be held in D.D.U. Hospital on **22/03/2017** for filling up of following vacancies of Junior Residents.

All eligible candidates who are interested for the same are requested to report at 9.00 a.m. on **22/03/17** at Seminar Room Ist Floor Administrative Block, D.D.U.H alongwith duly filled proforma annexed with this notice, a set of self-attested copies of all certificates and two passport size photographs. Original certificates/documents are also required at the time of interview for verification. **Candidates reporting after 12.30 pm. will not be considered for the interview.**

Only those candidates are required to report who fulfil the eligibility criteria as Residency Scheme and following crieteria.

ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT (ADHOC)

1. **Qualification :** MBBS degree from MCI recognized University/Institute
2. **Age limit:** For General candidates below 30 years as on **22/03/2017**, relaxable for SC/ST by 05 years and for OBC (Delhi) by 03 years. (OBC (Delhi) candidates are required to submit their caste certificate issued by the Competent Authority of GNCT of Delhi. The certificate should mention their belonging to non-creamy layer.
3. **Internship:** Must have completed compulsory rotary internship on or before the date of interview **but not before two years from the date of interview**
4. **Registration:** **Must have permanent DMC Registration as on date of interview.**
5. **Pay Scale:** Pay in pay band-3 Rs.15600-39000 plus Rs.5400/- grade pay (Pre-revised) and other allowances as admissible.
6. The candidates who have already worked as Junior Resident for two years shall not be eligible.

7. Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the interview and will be offered residency only if fresh candidates for the post of Junior Residents are not available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions (Vide Circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011, along with other relaxed criteria mentioned in the said circular).
8. **Benefit of reservation will be granted only on the basis of caste certificate issued by the competent authority and production of original certificate at the time of interview.**
9. **Residence Proof:** Voter ID Card/Passport/Driving License/Aadhar Card etc.
10. **Jurisdiction of Dispute:** In case of any Legal dispute, the jurisdiction of Court will be Delhi/New Delhi only
11. The service condition will be regulated as per the rules in the Residency Scheme, ministry of H&FW.
12. No TA/DA will be paid for appearing in the interview.
13. No correspondence or personal enquiries shall be entertained.

Note: - In case suitable candidates are not available in the reserved category, these posts will be filled by General category candidates.

Important:-

If any declaration/Information furnished by the candidate is found false/any material/fact suppressed willfully, the candidate appointment will be cancelled/terminated forthwith

The decision of the selection board/ Medical Director of D.D.U.Hospital regarding selection will be final and binding and no representation will be entertained in this regard.
