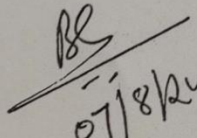

5. Mode of Selection : By interview (the applications shall be scrutinized and interview shall be held at DDU Hospital. No separate communications shall be sent to anybody.
6. Last date of Submission of Application : 06/09/2024 (Friday) upto 4 PM
7. Date / venue of Interview : 11/09/2024 (Wednesday) at 11 : 00 AM onwards

8. Scope of Work : All work related to concerned specialty / department
9. Duly completed applications in all respect (alongwith all supporting documents) must reach office of Medical Director, DDU Hospital, Hari Nagar, New Delhi-110064 latest by 6th September, 2024 (Friday) by 04 : 00 PM. Incomplete applications or application received late shall be summarily rejected.
10. The engagement of retired employee shall be governed as per terms and conditions mentioned in H&FW Deptt. letter No.F.JSHFW/2017/Plg./ssadminhfw/769-775 dated 13/10/2017 and Finance Department, GNCTD OM No.20/4/2015-AC/204-248 dated 4/12/2015. The terms & conditions are as under :

(i) The engagement of retired-government servants as consultant on contract basis shall be against the vacant sanctioned post.

- (i) The amount of monthly consolidated remuneration / fee in the case of retired government officials appointed as consultant shall be last pay minus basic pension plus DA at the applicable rate. However, a retired government official appointed as consultant shall continue to draw pension and the dearness relief thereon during the period of his engagement as consultant. His / her engagement as consultant shall not be considered as a case of re-employment.
- (ii) The retired employee is required to appear before a medical board for undergoing medical examination. The engagement will be given only after the candidate is found medically fit.
- (iii) The engagement can be terminated at any time (on either side) by giving one month's notice or by paying one month consolidated amount, without assigning any reason.
- (iv) The retired employee shall not be entitled to any benefit of provident fund, pension, gratuity, seniority which are available to the Government Servant appointed on regular basis.
- (v) The engagement of retired government as consultant should be against a vacant sanctioned posts. The engagement of consultant would be on full-time basis and they would not be permitted to take up any assignment during the period of consultancy;
- (vi) The engagement of consultant will be initially for a period of one year or till regular appointment, whichever is earlier. However, it can be extended further subject to the satisfactory performance of the consultant and depending upon the specific job and the time frame for its completion. The total period of engagement as consultant should not exceed five years. In no case the consultant should be allowed beyond 5 years. The maximum age limit of engagement shall be upto the attainment of age of 70 years.
- (vii) The consultants shall not be entitled to any allowance such as House Rent Allowance, Reimbursement of call charges of residential telephone / mobile, transport facility, residential accommodation, personal staff, etc.
- (viii) No government vehicle shall be provided to the consultants.
- (ix) No TA/DA shall be admissible for joining the assignment or on its completion. Consultant will not be allowed foreign travel at government expenses. However, consultant shall be allowed TA/DA for their travel inside the country in connection with the official work, if any, as per their entitlement as on the date of retirement.
- (x) Consultants shall be eligible for 8 days leave in a calendar year on pro-rata basis. Therefore, a consultant shall not draw any remuneration in case of his / her absence beyond 8 days in a year (calculated on pro-rata basis). Also unavailed leave in a calendar year can not be carry forward to next calendar year.

- (xi) The engagement of consultants is of a temporary nature and the engagement can be cancelled at any time by the department without assigning any reason.
- (xii) The retired employee to be engaged as consultant should be clear from vigilance angle. There should be NO vigilance case / complaint either pending or contemplated at any level.
- (xiii) These retired employee shall not be entitled to LTC for the duration of the contract.
- (xiv) The appointee shall not be entitled to any TA/DA for interview / medical / joining.
- (xv) The retired employee will not be entitled for leave of any kind for study during the contract period.
- (xvi) This engagement is purely on contract basis and will not bestow upon him/her any claim for regular appointment.
- (xvii) The appointee shall bear full responsibility of the work as prescribed in the duties. In addition, he/she will also be required to discharge the duties as and when required by any authority so authorized.
